Hope you are well? I wanted to confirm one of the items on the tracker regarding Mr Alston and sinking a deeper borehole. The wording on the tracker for issue number 30 (line 31) is as follows;

"Mr Alston has suggested that he is prepared to sink the borehole deeper- but has been held back from doing this because of the ongoing permit determination."

I know we briefly discussed this over lunch at the meeting on 23 May. We have had some discussions in the past with Mr Alston about drilling into the chalk, however our initial findings indicated that there was still potential for interaction with the surface features.

To my knowledge there are no outstanding discussions with Mr Alston regarding possible alternatives to his current abstractions.

Could you confirm whether you are happy to agree that this line on the tracker can be closed on this basis?
