BAWAG Change Process: Next Steps

We're finalizing the BAWAG re-branding and will run the Committee through the proposed changes when it meets on September 27 2022. Related to this, we're also updating the website – in part to make it mobile-phone friendly – and developing our proposals for a new organizational structure. This will reflect our transition to a Company Limited by Guarantee and so the requirement for the Committee to change into a Board that operates in accordance with agreed Articles of Association. A proposal will be put to the Committee for a membership meeting before Christmas so that you have a final opportunity to comment on all of this before the changes are made.

Ant Broads & Marshes Update

Since the last Newsletter, the Environment Agency has indicated that it will issue Section 52 notices to the affected abstractors in early October, initiating the appeal/objection process. We continue to work with the abstractors, the NFU, the Environment Agency, Natural England and the local planning authorities, with the time available to develop alternative sources of supply emerging as a critical issue. The Ant Valley Masterplan is the focus for this work, with the Environment Agency requesting more detail in this about specific schemes as a part of their process for considering an extension to the legal process.

NFU News

The NFU hosted a Norfolk visit by David Hallam, the Defra Director of Floods and Water. David spent the morning in the Upper Wensum discussing issues related to water quality and then came to the Broads for a visit to Place UK and G's salad leaf operations. Over lunch he was briefed on the changes we're making at BAWAG and the issues we're dealing with in respect of the Ant Broads and Marshes. We were able to impress on David the practical issues & complexities arising from the restoring sustainable abstraction program, as well as the need to safeguard agri-food in areas such as north-east Norfolk, where the combination of climate, soils & water is critical for our highly productive agri-food businesses

UKIA News

Irrigation Prospects

The UK hydrological outlook for August to October has been published by the UK Centre for Ecology & Hydrology (CEH). Prospects are for below normal flows, which will be exceptionally low in central and southern England. Groundwater levels in southern England are also likely to be exceptionally low through to October, although there is some uncertainty about the effect of autumn recharge. EA Irrigation Survey

As part of the Water for Tomorrow EU Interreg project, the EA are currently undertaking a survey to determine what impact water scarcity would have on abstractors. In relation to 20% and 50% reductions in water availability, the EA are seeking views on the impact of this on:

- Type of crop
- Crop yield
- Quality of crop
- Economics, and
- Work force

To help them with the survey, they are also seeking related information on sources of supply. The survey form is attached. If you have the time, please complete this and get it back to me – I will then collate our responses and forward them to the EA.
